Please read the manual carefully. Maytronics and its authorized partners shall not be responsible for any malfunction, faults, damage or injury resulting from a failure to store, handle or dispose of the battery correctly in accordance with the instructions.

Who are we?

We are Maytronics International, a company incorporated in Israel with our registered office address at Kibbutz Yizre'el 1935000, Israel.

How long does this commercial warranty last?

This commercial warranty starts on the date your pool cleaner was delivered to you or collected by you, as shown on your proof of purchase.

This commercial warranty will last for 24 months from the start date.

This is referred to as the “Commercial Warranty Period” below.

What does this commercial warranty cover?

This commercial warranty covers any defects in material or workmanship under normal use and service during the relevant Commercial Warranty Period for the original purchaser only.

The warranty is subject to the exclusions set out below.

This commercial warranty is invalidated if:

1. You have used the pool cleaner outside of its normal, recommended and reasonable use.
2. You have not stored the pool cleaner in the correct manner as listed in the user manual.
3. You have used the pool cleaner in a non-compliant pool environment as detailed in the user manual.
4. The defect(s), damage, malfunction(s) or failure(s) do not result from a manufacturing defect.
5. The pool cleaner has been altered, misused, or has been repaired by anyone other than a Maytronics-certified service station or technician.

Maytronics hereby disclaims any and all claims for damage (including to property, pool plaster or vinyl liner) resulting from the incorrect storage, use and/or operation of your pool cleaner in non-compliance with the user manual or written instructions accompanying the pool cleaner and linked above.

What does this commercial warranty entitle you to?

This commercial warranty entitles you to a repair or replacement during the Commercial Warranty Period of the motor cabinet, charger, electronic board and battery in the event a manufacturing defect has been detected, and the exclusions set out above do not apply.

What happens if a warranty exclusion applies?

If no manufacturing defect is discovered or one of the warranty exclusions applies, this commercial warranty will not apply and the unit will be returned to you at your cost.

Severance

If any court or relevant authority decides that any of the limitations or exclusions in this commercial warranty are unenforceable, this warranty will be deemed modified to the minimum extent necessary to make it enforceable.
